1) These Games assume risks of injury, deterioration of health, including possible permanent paralysis and death. 4) I, on my own behalf and on behalf of my heirs, successors, personal representatives and next of kin, hereby release from responsibility and prosecution the Organizing Committee of the Games, their employees, officials, agents, and / or employees, other participants, funding organizations, sponsors, advertisers, and, as appropriate, owners and lessors of the premises in which the Games are held (“exempted persons”), in the event of any injury, disability, death, damage or damage caused to a person or property due to the negligence of persons exempted from liability, or the reason fully authorized by law.

5) I hereby consent to the Organizing Committee of the Games to photograph and record my voice and speeches, as well as the use of my photographs, silhouette images and other materials intended to reproduce my appearance and voice, for marketing purposes within this event and events that will be held in subsequent years.
